The modification will be an extension of current services with the existing provider. The proposed length of the contract will be for 12 months and will commence on 01/04/2025 and end on 31/03/2026. The additional value of the contract based on the indicative contract budget for the previous 3 years will be £298,000.

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

It was the intention that a Single Point of access using a digital platform, which also presents the option of onward referral including other services traditionally delivered in Primary Care would be procured from 1 April 2025 on a SY wide basis. However, due to financial pressures within the ICB and therefore unable to progress through a route for investment for the planning round 2025/26, places have no alternative but to procure services locally until this is resolved.

Considering the circumstances and the timescales of undertaking a full procurement a Modification notice for a 12-month period is required to allow for this work to be undertaken. All places have agreed to work collaboratively to progress this in developing a SY ICB service specification for Community Eye Care alongside progressing the SPA option.
