The contract modification is in accordance with Regulation 72(1)(b) of the Public Contracts Regulation 2015 for an additional two (2) years until 31/03/2024. This modification increase in price does not exceed 50% of the value of the original contract

(2012/S 053-085884). The contract was extended by two (2) years until 31/03/2019 in accordance with the original contract (06/03/2012) and a CCN (31/03/2017).
