Through the commissioning of 16+ Accommodation, The Council aims to keep children and young people as close to home as possible to enable them to remain part of their communities and retain their childhood connections.

The Council is looking to commission supported accommodation and support for young people aged 16-plus via 3 lots:

- 1) Management of Springboard Houses and Training Flat.
- 2) Semi-Independent Accommodation.
- 3) Floating Support.
