programme therefore can only be conducted in certain Laboratories in the country. After consideration including a key considerations form the decision has been made to award to The Newcastle Upon Tyne Trust using the Provider Selection Regime Direct Award C. The trust has a current SLA in place with NUTH for the service and has established that no changes will be made to the service. The contract will be awarded for 2 years and will be to the value of 164,000 including VAT. The service is to commence on 01-04-2025 until 31-03-2027.
