Due to the nature of the estate which is mainly legacy and old there is significant work already in play to transform the BAU estate which covers multiple sites across Sussex, Hampshire, IOW and Kent. The transition of the old BAU and Legacy estate which is in transformation stage would be time consuming, complex and add little value to the various current programs running and could cause much disruption to exist BAU service and project programs in this period.
