The ADMC is a flagship project for Ashfield District Council. The ADMC will work with businesses to create and implement bespoke automation strategies and solutions that improve productivity and enable prosperity and growth.

The ADMC will be a 3,000m<sup>2</sup> purpose built, multifunctional, automation centre. Its vision is based on four "pillars" of activity:

- Research and Development
- Prototyping and Proof of Principle
- Showcasing and Demonstration
- Skills and Training

The ADMC will be at the centre of a cluster of automation businesses, some of which will be located on the adjacent Ashfield Innovation and Technology Park that is also in development.
