As set out in that document, Genomics England has currently selected 9th May 2022 as its intended deadline for responses to the questionnaire, although it reserves the right to extend that deadline as it considers appropriate.

Interested potential partners who register an interest are encouraged to participate in conversations with Genomics England to help them understand our objectives and answer their queries. This will be able to be done through completing the questionnaire referred to above, asking Clarification Questions (“CQ”) within the e-tendering portal and by attending the Market Consultation event on 27th April 2022 where an overview of the project will be presented and an opportunity for 1-2-1 meetings will be possible. Further information relating to the Market Consultation Event will be published within the Bravo e-tendering portal.

This Market Consultation will be managed through the Bravo e-tendering solution.
