NHS England is intending to modify the framework agreements entered into under the ICF to include the process through which providers may request (i) additions to the services they supply under their framework agreement and/or (ii) the inclusion of additional sites at which the provider is permitted to offer services.

NHS England has concluded that the proposed framework variation falls outside the scope of application of the directive as the modification will introduce the processed change control mechanism which is not a substantial change to the ICF (as defined in Article 72(1)(e)).

The original procurement documents did envisage that existing providers would be permitted to increase the scope of the services that they offered under the ICF provided such additional services were within the scope of the ICF services.
