permanent population at Risk of approx. 17,800 which increases substantially during the summer months due to tourist arrivals therefore the requirement to respond to any incidents or emergencies within the SBAs.

This requirement is for the purchase of three front-line ambulances along with commercial delivery, training and ongoing warranty/maintenance.
