### **Description**

NHS South East London ICB and the Dysart Surgery (hereafter referred to as "the Authority") are seeking to commission GP Facilities Management Services for the Bromley Health & Wellbeing Centre to a single provider.

The proposed contract duration will be an initial duration of 3 years with further options to extend for 1 year + 1 year, equating to a maximum contract duration of 5 years.

The initial contract value for the first 3 years will be £100,000 GBP per year or £300,000 for the initial 3 year term.

The contract will be between the successful provider and the Dysart Surgery.

The facility is the first floor of an existing building, Churchill Court in the Bromley Town Centre which is owned by the London Borough of Bromley and leased by Dysart Surgery. The facilities management services are the tenant's (Dysart Surgery) responsibility under the terms of the lease.
