The Centre was stocked with a large suite of high-end SCIEX mass spectrometers, including TripleTOF® 6600 Systems and QTRAP® 6500+ Systems and associated equipment for clinical proteomics and metabolomics applications. The Centre works to a quality system and has a dedicated IT infrastructure for the management and assessment of the data produced. unsuccessful shall be informed by the authority as soon as possible after the decision has been made as to the reasons why the applicant was unsuccessful. If an appeal regarding the
