Contract length: the contract is for a period of 3 years with the option to extend by up to a further 2 years. The contract commencement date is 1st April 2023.

The ICB set an indicative financial envelope for a maximum block annual contract value of £2,455,000 per annum. The successful bidder achieved the highest overall score and came within the indicative threshold at a cost of £11,885,000 for the duration of the contract (including extensions).
