- Application technologies in scope include RHEL, Oracle Database, Oracle APEX, Business Objects, Apache Tomcat, Angular, Spring and Jasper Reports.
- Support the existing DevOps delivery approach and maintenance of the automated CI/CD pipeline is also required.
