Infant/Junior halls/dining areas.

? Floor care including vacuuming, mopping, half termly Infant/Junior Hall floor polishing and periodic deep cleaning.

? Weekly wiping over window seals / door frames.

? Waste and recycling collection and disposal from the school building.

? Supply and management of cleaning materials and equipment.

? Periodic and ad-hoc deep cleaning services as required.

A detailed cleaning specification, schedules, and performance standards will form part of the final contract.
