Healthy Urban Places (HUP) at The University of Liverpool (UoL) is seeking a community-based organisation (or organisations) experienced in community engagement, and with established community networks, to collaborate and contribute to "Community Collaboratives" and support the delivery of research for the Healthy Urban Places (HUP) programme.

Healthy Urban Places, funded by UK Research and Innovation and part of Population Health Improvement UK, is exploring how and why local environments (e.g. housing, local amenities, access to jobs, availability of community or social spaces, the way decisions are made or resources invested) influence people's health and inequalities, through
