Most Services will operate a model of shared care and may provide 24-hour Staff on site, where Staff work night shifts, either waking or sleeping at the Service. The Service Provider and the Council will discuss the support model at an early stage.

The Service will provide a place of safety, security and stability.

If the Service Provider is sourcing accommodation, they must meet the accommodation standards as detailed in the Specification.
