Portsmouth City Council intends to award a contract to an existing provider for the provision of an existing service, The Towards Better Health (TBH) partnership, following Direct Award Process C under the Provider Selection Regime (PSR) Regulations 2023.

Portsmouth City Council was awarded funding from Public Health England and the Department for Housing, Communities and Local Government (DHCLG) as part of the rough sleeping drug and alcohol treatment grant.

The aim of the service is to improve support and outcomes for people experiencing rough sleeping who have drug and alcohol dependence needs.
