This is a Provider Selection Regime (PSR) intention to award notice. The awarding of this contract is subject to the Health Care Services (Provider Selection Regime) Regulations 2023. This contract has not yet formally been awarded; this notice serves as an intention to award under the PSR. The decision to award the contract was made by the Chief Strategy & Population Health Officer. • No declarations of actual, or potential interests by those officers involved in this decision. • The incumbent provider has delivered the following key criteria 1: Quality and Innovation with a value of 27% by achieving the contractual KPIs, 2: Value with a score of 16% by providing a service that is value for money compared to other providers, 3: Integration, collaboration and service sustainability with a value of 16% by collaborative working within the local system, 4: Improving access, reducing health inequalities and facilitating choice with a value of 16% by reducing health inequalities, 5: Social Value with a value of 5% by ensuring the provider is meeting London Living Wage (LLW). The existing provider is satisfying the original contract and will likely satisfy the proposed contract to a sufficient standard.
