The population covered by this service are resident in the administrative county of Hampshire (or registered with a Hampshire GP) and meet the acceptance criteria.

The service will be paid on performance and the total value stated is up to £2,290,000.00.

- f. People living in the three most deprived Hampshire deciles of deprivation
- g. Men

- j. People with learning disabilities

- Population aged 18+ years with a BMI ≥ 30 (BMI ≥ 28 black/minority ethnic origin or those with specified long-term conditions), resident in the administrative county of Hampshire or Registered with a Hampshire GP
