Waymont is the Original Equipment Manufacturer (OEM) of both the TIGERTRAP hardware and LIGHTNINGSHIELD software solution under a proprietary design that was approved by the National Cyber Security Centre (NCSC). Only Waymont has the requisite technical know-how, tools and means, including proprietary documentation and information to carry out the services required. Waymont is not prepared to authorise any third party to use its proprietary information and the MOD does not hold, nor does it have the right to obtain or use, the necessary documentation or information from Waymont and cannot authorise a third party to carry out maintenance work to either the software or the hardware.
