This new facility will create an epicentre for campus life and facilitate the increased engagement of the whole student body. In order to operate the building to world class standards a new building operations team will be formed. This new multi-disciplinary facilities and operations team, led by Queen's Operations Manager, will manage and co-ordinate all aspects of building operations on behalf of all users apart from some services that the Students' Union and Student Plus Commercial Services will self-deliver.
