It was deemed that this approach was putting the council's staff in danger and not effectively communicating the required messages. We've sought a quote to retrieve the filled packs from the Council, to supply replacement envelopes and print residents' postal addresses, then mail them to homes using a Royal Mail economy postal service, on the Council's behalf.

Due to service changes & price increases coming into force in April 2025, and for a continuation of the service-in-progress, we do not have time to complete another competitive tender procedure, which will slow the process & we need to ensure we stick to the delivery on a tight schedule.
