This service provides interventions to those adult (age 18 and over) men and women who wish to change their own abusive behaviour, with the aim of reducing that behaviour and making victims and their children safer. The service must provide outcome focussed individually tailored safety and support plans for victims which shall be reviewed regularly throughout time in service. The service shall work collaboratively and in a co-ordinated manner with other local and national specialist services working with perpetrators of domestic abuse and victims of domestic abuse.
