A Cranial patch is made of synthetic, biodegradable nanofibers meant to be affixed to the dura mater - the protective membrane underneath the skull that keeps the brain and spinal cord safe after cranial neurosurgery. A Cranial sealant is an adjunct to standard methods of dural repair, such as sutures, to provide watertight closure during both cranial and spinal procedures.

Lot 3C: Cranial Closure - Cranial Clips and Pins. Cranial clips and pins are designed for being attached to the scalp flap for safe and adequate haemostasis during a craniotomy procedure.
