The FCDO (the Authority) is looking to put in place a contract with a supplier for the provision of administrative services to run two short educational programme for mid-career professionals. The first programme is for professionals from India and the second for professionals from Western Balkans countries (Albania, Bosnia and Herzegovina, Kosovo, North Macedonia, Montenegro, and Serbia).
