Lincolnshire County Council is working with North and North East Lincolnshire Councils on the re-commissioning of Sexual Health services and it is proposed a 'Greater Lincolnshire' approach will be taken.

These services include:

- A countywide integrated sexual health service which includes a service for children and young people across North and North East Lincolnshire.
- A countywide integrated sexual health service which includes a service for children and young people and Emergency Hormone Contraception in pharmacy locations across Lincolnshire.
- Long-Acting Reversible Contraception via GP practices across Lincolnshire
- Sexual health outreach, HIV prevention and support service across the Lincolnshire area.
- Sexual health outreach, HIV prevention and support service across the North and North East Lincolnshire area.

All of the above services are in scope for this re-commissioning, with some having been in place since 2016.
