The original NaFRA2 Contract Award Notice

(<https://ted.europa.eu/en/notice/-/detail/209496-2020>) was published on 1st May 2020.

The "Total value of the contract" was published at £8,047,000.

The Environment Agency has placed a number of contract changes under the contract, to an additional value of £4,450,000, including the addition of flood risk data products and a

sizeable increase to the charges (primarily due to inflationary clauses that were included in the original contract documents).

In the interests of transparency, the Environment Agency wishes to declare that the cumulative final value of the NaFRA2 contract is anticipated to be no more than £14,500,000 with the contract expiring no later than 15th October 2027 (based on a 4.5+1+1+1 contract term).
