In accordance with the provisions of the Procurement Act 2023 (PA 2023), the award of the contract without prior publication of a contract notice in the UK e-notification service is deemed lawful under Schedule 5, paragraph 13 of the PA 2023. This exemption applies because the goods, services, or works required under the public contract are strictly necessary due to extreme and unavoidable urgency, preventing the contract from being awarded through a competitive tendering procedure.
