‘This is a Provider Selection Regime (PSR) intention to award notice. The awarding of this framework agreement is subject to the Health Care Services (Provider Selection Regime) Regulations 2023. For the avoidance of doubt, the provisions of the Public Contracts Regulations 2015 do not apply to this award. The standstill period begins on the day after the publication of this notice. Representations by providers must be made to the relevant authority by 10th March. This framework agreement has not yet been formally concluded; this notice serves as an intention to establish the framework agreement under the PSR.’

This framework agreement has been concluded under the Health Care Services (Provider Selection Regime) Regulations 2023. For the avoidance of doubt, the provisions of the Public Contracts Regulations 2015 do not apply to this award. This framework agreement has now been formally concluded using the competitive process.’ The standstill concluded on the 10th March 2025. The agreement will be in place for 4 years. The lifetime value of the agreement is £20,000,000 maximum.
