PROPOSED CONTRACT: As part of the procurement process for the replacement contract in 2023, NHG wishes to carry out pre-procurement market engagement in order to seek views

from the market about its proposals before the formal launch of the procurement through the issue of a Contract Notice on the Find a Tender Service.

NHG 's current proposed strategy is to award a sole supplier to cover all requirements.

Currently it is proposed that the contract duration will be up to ten years (with an initial four year term, which can be extended by one periods of four years, and one period of two years).

ABOUT US: Notting Hill Genesis is one of the largest housing associations in the country, with more than 66,000 homes across London and the south-east. PROCUREMENT PROCESS: NHG may elect (at its discretion) to proceed with the procurement of the proposed contract. At such time as the procurement proceeds, a contract notice will be issued in the Find a Tender Service which suppliers will be required to respond to if they wish to bid for the opportunity. We intend to follow the Restricted Procedure, which is a two-stage process. The Selection Questionnaire (SQ) stage is likely to start in early June 2022, with around 4 weeks allowed for bidders to respond. The Invitation To Tender (ITT) stage is likely to start in August 2022, with around 5 weeks allowed for bidders to respond. The procurement timetable will be confirmed to bidders once the SQ stage begins.

CONTRACT VALUE: based on NHG's current anticipated requirements and on the maximum potential length of the estimated contract value is £15,000,000. NHG cannot give any guarantees that works totalling this value will in fact be performed through this contract. Equally, the total value may increase if NHG's own requirements increase unexpectedly.
