The ETF are seeking one delivery partner who will be able deliver both strands and develop and expand the programme further. The two strands of activity making up this requirement are set out in further detail below:

1. The development and delivery of a national programme of CPD to enable English, English for Speakers of Other Languages (ESOL) and Essential Digital Skills (EDS) teachers to undertake collaborative action research projects.
2. The design and pilot of two FutureLearn courses: one on how to conduct action research in Further Education and one on how to lead or support research projects in Further Education settings.
