Access to tests and expert opinion for patients with the following:

Dyspepsia (with alarm symptoms, non-responsive to therapy or unexplained, H pylori not responding to second line therapy, or gastro-oesophageal reflux disease considering surgery)

Oesophageal Dysphagia.

Abdominal discomfort and altered bowel habit not fulfilling criteria for irritable bowel syndrome.

Rectal bleeding.

Iron deficiency anaemia (as per NICE guidelines for referral).

Acute management of:

GI bleeding.

Inflammatory bowel disease.

Gallstone and pancreatitis.

Nutritional problems.

Chronic management of:

Chronic GI morbidity after cancer treatment.

Coeliac disease.

Barretts oesophagus.

Functional gastrointestinal disorders not responding to standard therapies (e.g. exercise and diet, pharmacological, psychotherapeutic interventions).

Inflammatory bowel disease.

Endoscopic surveillance and screening in high-risk individuals

Post polypectomy or colorectal cancer resection.

Patients at hereditary risk of colorectal cancer.

Other high-risk groups according to published guidance, e.g. acromegaly, cystic fibrosis, patients with ureterosigmoidostomy, long standing (>10years) inflammatory bowel disease.
