### VII.2.2) Reasons for modification

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

The additional services have become necessary: there was a required pause in procurement preparation activity due to the 2024 General Election meaning plans for

future provision were not confirmed. An extension to the contract for an additional cohort was necessary until the new government's strategy for the programme is confirmed. A preliminary market engagement notice for the future provision of the service will be published on Find a Tender Service.

There are economic reasons why a change of contractor cannot be made – the Authority considers that if a procurement were to be run for the additional cohort, the start-up costs for a new supplier, and the time and cost associated with the procurement, would be disproportionate. The Authority considers that there are no appropriate frameworks available.

The value of the additional services will not breach the 50% value threshold for reliance on Regulation 72(1)(b).
