This is a non-clinical service and does not provide neurodevelopmental diagnoses.

The service works with a range of providers to deliver mental health and neurodevelopmental support to children, young people and families across the different levels of presenting need. It be destabilising to go out to competition due to the collaborative nature of the services in Liverpool.

The provider has also demonstrated excellent performance, proven value for money and that the services provided can prevent difficulties from escalating as well as providing accessible support to children, young people and families who are waiting for more specialist interventions.
