The young people accessing this service will have involvement with social care or be at risk of homelessness, with the service designed to prioritise 16 and 17 year olds and care leavers up to the age of 24 years.

The intended outcome for young people in supported accommodation is that they are provided with an environment where they can thrive and receive a safe and supportive transition to adulthood and independent living.
