contract):

Following the modification, the awarded contract value has increased by £50,709,374, bringing the total to £149,748,406 from the initially committed value. The awarded premises have increased by 21,107, resulting in a total of 53,536 premises from the original 32,429 committed. These volumes, along with the commercial builds and other program approaches, will achieve the 99% coverage target. The deferred scope models have now closed.
