The FCDO is seeking a Principle Contractor to deliver Electrical Infrastructure Upgrade works at FCDO's office base in Abercrombie House, East Kilbride, Scotland.

The scope of works will likely include:

- New generator infrastructure circa 1.5MVA across two units
- New UPS infrastructure circa 2x100kVA in a 2N configuration
- New main LV panel installation of a 2000A form 4 type 6 panel of circa 58 ways including generator controls
- Strip-out of redundant electrical infrastructure throughout
- Requiring of 11 minor communications rooms and 1 major communication room

The Successful Contractor will be required to have experience in larger scale works, knowledge of high voltage and low voltage systems and working with transformers inside and outside building.

The procurement is planned to commence in the coming months, with an anticipated award date of June 2023 and contract start date of July 2023 (subject to change). The anticipated works duration is 12 months.
