The accommodation shall also provide onsite facilities for staff and communal areas for group work etc. The provider will be responsible for the levy and collection of accommodation charges from individuals placed in each unit and the associated housing costs assistances available for low-income residents.

The Provider of this service will be a key partner in the delivery of the outcomes of Dumfries & Galloway Council's Homeless Strategy, Rapid Rehousing Transition Plan, Dumfries & Galloway's Children's Services Plan and Dumfries & Galloway Council's Corporate Parenting Plan.
