Mersey Care NHS Foundation Trust (MCFT) intends to contract with Liverpool University Hospitals NHS Foundation Trust (LUHFT), Lower Lane, Fazakerley, Liverpool, L9 7AL for

the provision of clinical and diagnostic services for patients and service users of Mersey Care NHS Foundation Trust. The contract value is approximately £484,660.

MCFT is currently in contract with LUHFT for these services. For the new contract MCFT requires the service to be mobilised from 01 April 2024 for a period of 12 months.
