The requirement has an estimated start date of 04 Jan 22. To meet

operational requirements, the Contractor will train students to use an Electro Optical/Infra-Red sensor in the airborne environment to achieve the training standard set by the MOD. The students should receive training in the use of the sensor, a modern mission system and perform the duties of a pilot's assistant in the cockpit environment. Students will have completed the following military training courses before arrival with the Contractor: Military Aviation Ground School and Mission Aircrew (MA) ISR Foundation Phase. Details of these courses will be provided.
