#### II.2.4) Description of the procurement

This service is being funded from a pilot programme to help the NHS respond to its long-term plan requirement to provide additional support for the most vulnerable children and young people with complex needs. This is being driven by a new policy document call called the Framework for Integrated Care (soon to be published). In this document there are several key outcomes, which are:

- Improved CYP wellbeing that are identify as vulnerable with complex needs
- Reduction in high-risk behaviors e.g., self-harm, youth justice system
- Reduced mental health concerns of CYP that are identify as vulnerable with complex needs
- Improved stability of home either with family or carer
- Improved purpose for CYP aiming for CYP to stay in and achieving in education, finding training or a job that they want to do.
- Organisations working with these CYP are more trauma informed
