- Low risk structural repairs.

Lot 2 Complex Civils (PD & PC Required): Design and build works where suppliers hold design, safety, and delivery responsibility.

- Complex drainage systems.
- Retaining structures.
- High risk groundworks.
- Works requiring temporary works design.
- Projects requiring full CDM compliance with the supplier acting as Principal Designer (PD) and Principal Contractor (PC).

Lot 3 Interior Renovation: Interior works, including plastering, electrical works, and refurbishments via specialist suppliers.

- Plastering and drylining.
- Joinery and carpentry.
- Electrical installation and rewiring.
- Plumbing and heating works.
- Flooring installation.
- Painting and decorating.
- Full interior refurbishments of rooms, offices, or facilities
