The contract will be awarded by NHS South East London ICB (hereafter referred to as "The Authority") to the existing provider following a Direct Award Process C for the following services:

Tier 3 Intermediate Community Dermatology delivers treatment for a range of non-complex care to Bexley and Greenwich residents in community settings closer to patients' homes. The service is a consultant-led service, operating between existing Primary Care and Secondary Care services. The service operates in 6 locations across the boroughs of Bexley and Greenwich. Uniquely, this service offers a step-up and step-down (from LGT) service, and the capability of putting patients requiring urgent appointments directly into a secondary care clinic appointment when clinically appropriate. The service also operates via a RAS, and benefits from the strong relationship with LGT Clinical Dermatology Lead who provides mentoring to GPwERs, triage support / guidance to the service clinical lead.

Due to the current provider currently meeting all contractual requirements to a satisfactory level, it is the intention of the authority to enter into contract for the period of 01 April 2025 to 31 March 2028 with an optional two-year extension.
