The participating authorities are Blackpool, Bolton, Bury, Manchester, Rochdale, Oldham, Salford, Stockport, Tameside, Trafford, Wigan, GM Fire & Rescue, GMP and Transport for Greater Manchester as part of the Greater Manchester Combined Authority, Kirklees and West Yorkshire Fire & Rescue. Other associates (Cheshire East and Warrington) are entitled to call-off from this framework if they so wish, however their requirements do not form part of the initial scope. Each Organisation that wishes to use the framework will enter into their own contract with the successful bidder by way of a call-off order. The wholly owned companies and Arms-Length Management Organisations (ALMOs) of the above-mentioned organisations are also entitled to use this framework.
