NRW is seeking to award a contract for the supply of 2 x All Terrain Very Low Ground Pressure Multi-Purpose Tracked Vehicles. The vehicles will be based at both NRW's Bryn Mwcog Workshop and Llwynawel Workshop and will be used on a range of wetland NNRs & other wetland designated sites in Wales.

Some of the wetland sites are on mineral soils and are seasonally dry, but the majority are on peat soils which are wet all year round with an extremely low load bearing capacity.

The key purpose of tracked ATVs:

- Access most of the wetland sites.
- Carry a minimum of 3 persons
- Carry loads of over 1500kg on site
