The nature, level and duration of supports vary depending on the Service User's level of care and support requirements. The Service is person centred, flexible, responsive, supportive and empowering and reflects the needs, outcomes and aspirations of Service Users, their carer(s) and families.

The Service is delivered 24 hours per day, 52 weeks per year including public holidays. The size of each individual package of care varies and is dependent on the individual's assessed needs and outcomes.

Those in receipt of the Service will be predominantly people aged 65 and over and by exception other adults with relevant support and health needs, families with children and other vulnerable groups with housing support needs.

- Physical frailty
- Sensory impairments
- Dementia
- Complex care needs
- Vulnerability
- End of Life and Palliative Care
- Learning difficulties
- Physical disabilities
- Addiction problems
- Mental health difficulties
- Other long-term conditions
