Broadly, the partner(s) will help us identify the transformation workstreams, intervention areas, implementation plan, continuously adopt the plan as per the feedback and learning and execute the plan to drive the shift towards Agile organization.

The transformation office team will predominantly be based in the UK - Wokingham office with some flexibility to have PMO resources based in offshore/ nearshore. The UK based members will be expected to be in the office for 2/3 or more days depending on the critical meetings or events. Some Travel to NGESO's Warwick office will also be required.

We are reaching out to the experienced partners outside of National Grids Application Development and Maintenance framework (ADAM) and General Management Consultancy (GMC) framework as this engagement doesn't focus on application development (AD), application maintenance (AM) and business management consultation (GMC).
