To be considered, suppliers are expected to visit the site prior to submitting a detailed response to ensure they satisfy themselves with replacement requirements and submit an innovative response that could ensure compliance and value for money.

Removal, Supply and install of all Play Equipment and Associated EPDM Surfacing:

- Removal and replacement of all existing equipment including footings and fixtures. (Not the Daisy Talk Tubes)
- Removal and replacement of all existing EPDM surfacing, and Tarmac surfacing as required.
- Replacement Play equipment to include swinging, climbing, sliding, being high up, imagination and spinning.
