From the Commencement Date and for the full Term (including extensions) of the Framework Agreement and Customer contracts, all Providers shall be accredited and hold a current and valid health and safety accreditation (e.g., CHAS or equivalent) in line with theSSIP core criteria and be able to evidence independent re-validation of these modules when requested annually by the Customer.
