Borders Housing Association will be a named participant however, other named participants may also be added which will be detailed in the tender documents. SBc Contracts are the significant trading organisation of Scottish Borders Council delivering the roads maintenance programme as well as construction of Capital investment works. SBc Contracts have become a well-recognised key player in the construction industry undertaking works in the Public and Private sectors in southern and central Scotland and beyond.

The Framework Agreement will have multi-value and multi-supplier lots, further detail will be provided within the tender documents.
